Under categories a) - c) we have listed all persons who may be the beneficiary of a survivor's benefit; other persons will not be considered. Furthermore, only those persons in the same category may be named beneficiaries. There are additional restrictions for those receiving a spouse's pension and for divorced spouses. You should therefore read the applicable regulations.

Data protection

All personal data will be processed in accordance with the current legislation:

For compulsory occupational benefits, the data protection regulations of LOB (Art. 85a ff. LOB) apply. The provisions of the FADP apply in addition.
